## INTRODUCTION

Dear Colleagues,

Our Commission completed the four year period of activity since Cologne Congress. For me, personally, it means that I finished my second term as a chair and this introduction is the last one prepared by myself. Among the latest activities, I would like to emphasize our sessions in the Beijing IGU Congress, as well as our latest publication outcomes. I also summarize some news concerning the IGU and our Commission, as it is entering into next four year period with some important changes.

The Commission had three days with sessions during Beijing IGU Congress. Although final number of contribution decreased, due to absence of more colleagues that planned to be in Beijing, there was a very interesting variety of fascinating presentations. We had pretty nice global participation, with good mixture in age and gender. We also enjoyed plenary sessions, as well as excursions during and after the congress. Although IGC in Beijing had been a huge event (the largest IGU Congress ever), it was very well organized in an inspiring environment.

The Commission publishing initiatives culminated once again during the previous months. Two important publication projects had been completed – one journal special issue and one monograph. As far as journal special issue is concerned, I would like to thank above all colleagues Tadeusz Strykiewicz and Tomasz Kaczmarek, as well as other colleagues and journal editorial team from AMU University in Poznan. They developed a long term effort leading to the completion of a special issue on governance in the scientific journal *Quaestiones Geographicae*. We also appreciate all contributors in this special issue. The second outcome, the scientific monograph (“Local Government and Urban Governance in Europe”) published by Springer, appeared only few weeks ago. In this case, Carlos Nunes Silva had the major role as the first editor. He paid extensive attention to this book for months. On behalf of the Commission and all contributors I would like to express our thanks for his long term work and patience in dealing with various problems related to book editing. We are also grateful to all colleagues from Springer International for their very professional approach to this publication. Many thanks also to all colleagues contributing to this book.

The IGU Congress is always accompanied by set of “news” resulting from meetings of the IGU main bodies. Two important decisions had been adopted that I would like to stress.

The first one concerns the site of the 2024 IGU Congress. It was decided that this congress will be held in Dublin (Ireland), which won over Prague, Melbourne and joint candidacy of Malmö/Copenhagen. The second important decision concerned the change in the position of IGU President, due to the fact that Professor V. Kolossov finished his second term in office. As a result of elections, Professor Yukio Himiyama from Japan is now new president of IGU. For other changes in IGU Executive see [www.igu-online.org](http://www.igu-online.org). Among other issues, important change concerns the strategy for the organization of regional conferences, which will be organized as before only as one event in between two congresses. IGU also introduces new larger conferences „format“ of thematic conferences (starting in 2017).

As far as our Commission is concerned, as a result of the Beijing IGU congress, we are primarily pleased that our Commission will continue. Nevertheless, with respect to IGU rules, there are changes concerning the Commission Chair, as well as extensive changes in the Steering Committee composition. On behalf of all Commission members, I would like to thank all Steering Committee members whose term finished in 2016 (*Eiki Berg, Christine Bichsel, Taro Futamura, Shannon O'Lear, Pushkar K. Pradhan, Andrew Ryder and Xiaohong Zhang*). They very actively contributed to the Commission activities in meeting organization, editorial activities, reviewing of conference contribution etc. I hope that they remain participating in our activities in the future as well. Turning our attention to the future, I would like to congratulate Professor Carlos Nunes Silva for taking position as new Commission Chair. He is working for the Commission for years, and now he will have chance to use his manifold experiences for the Commission even in wider scale. I also congratulate new Steering Committee members - *Jiesheng An, Olga Glezer, Ilona Pálne Kovács, Yosuke Maeda, Bríd Quinn, Peter Schmitt, Anna Trono*. We suppose that they will extend their previous work within the Commission and use their expertise in doing research in various aspects of governance.

Among Commission personal news I would like to share with all members of the Commission the first appointments for honorary membership of the Commission. We consider this as a form to express our gratitude to long-term members, with deep personal involvement in Commission activities. We expect that *Professor Robert J. Bennett, Professor Doris Wastl-Walter and Professor Eran Razin* will remain in close contact with Steering Committee and will provide very important feedback and advisory role in shaping Commission activities also in future.

As “outgoing” chair I would like to thank many other colleagues that work with me, and their contribution to the Commission activities during the period 2008-2016. We are working in a very exciting field, with potential to provide relevant useful results for our societies. I always felt privileged by the opportunity to act as a Commission chair. I tried to do my best, although I am fully aware of many limitations in my work. I believe that I can still contribute a bit, as Steering Committee member in future.

## **COMMISSION SESSIONS DURING IGU 2016 CONGRESS IN BEIJING**

The Commission sessions in the 2016 IGC were very successful. Our Commission activities lasted three days and were organized into four sessions:

- *Geography of Governance - In Search for More Inclusive Governance*
- *Geography of Governance - Environmental Governance – Spaces, Actors and Powers*
- *Geography of Governance - Citizen E-participation in Local Governance*
- *Geography of Governance - Innovations in Public Sector, Public Administration and Public Services.*

The original interest to participate in our sessions exceeded 50 presentations (abstracts submitted). From these, 43 papers and 5 posters were accepted for the Congress. Finally, during the main congress programme we had 26 interesting and well elaborated papers, representing researchers based in 15 countries all around the world. Unfortunately many participants could not take part from various reasons (mostly due to insufficient funding). All contributions were allocated into eight time slots. The session focusing on environmental governance was the largest one in number of papers presented. As usual, besides well experienced scholars, or long term members of the Commission, we were very pleased by participation of many young scholars, primarily PhD students.

The attendance during our sessions oscillated from 15 to 30 persons, reflecting the capacity of the room in which we were based during the Congress. A reasonable number of presentations per time slot (mostly 3-4), leaved enough time for comments and questions. We were very pleased by a friendly and open minded atmosphere. As an advantage we consider the fact that all our sessions were held in one room and in consecutive time slots, immediately after the opening of the Congress. During the sessions we enjoyed excellent assistance by young volunteers, with Lianglin Liao working for us during all sessions. I would like to thank the Beijing IGC organisers for their long term involvement and communication concerning the preparation of our sessions. The organization of the Congress in general, as well as the flexibility applied in the running of our sessions are highly esteemed.
